Dear ones,

### **WOULD YOU TAKE THIS OATH?**

Lately there has been a lot of advertising on TV by the Shriners, those Freemasons in the red caps, asking for money to operate their hospitals for children. To become a Shriner, one must take a death oath to protect its so-called secrets (they really have no secrets). In the oath, the initiate kneels before a Muslim altar, puts his hand on the Koran, and swears that, if he violates the oath he will submit himself to the following punishment: “In willful violation thereof may I incur the fearful penalty of having my eyeballs pierced to the center with a three-edged blade, my feet flayed [cut across into thin strips] and be forced to walk the hot sands upon the sterile shores of the Red Sea, until the flaming Sun shall strike me with livid plague, etc.” And the death oath is sealed as the initiate calls upon Allah to help him to live up to his oath, as follows: “May Allah, the god of the Arab, Muslim and Mohammedan, the god of our fathers, support me to the entire fulfillment of the same, Amen, Amen, Amen.” (emphasis mine)

### **BUT WHY DO THEY WEAR THE RED CAPS?**

The red cap that all Shriners must wear is called a “fez.” Its name is derived from the city of Fez in Morocco. In the 8<sup>th</sup> century, Fez was a Christian city; but it was conquered by Muslims. Its Christian inhabitants were slaughtered until their blood actually ran in the streets. The exultant Muslims celebrated the slaughter by dipping their wool caps in the blood of the Christians, and wearing them in triumph. Ever since that terrible time, the red fez celebrates the slaughter of the Christians and the establishment of Fez as a Muslim city. It is the national head cover for men in such Muslim countries as Egypt.

### **BUT WHAT ABOUT THE HOSPITALS?**
