Dear ones,

Truth is a rare commodity today, especially in our Federal Government. For years I spent a great deal of time in Washington, D.C., dealing directly with members of Congress, working behind the scenes for the abandoned POWs in Southeast Asia. I attended every session of the Senate Select Committee on POW/MIAs (the ultimate cover-up of governmental treachery, fronted by John Kerry and John McCain). Day after day, I watched the systematic, obvious project of shamelessly intimidating and discrediting testimony from witnesses with first-hand knowledge of the truth and evidence, of which I was one of the very least. The days that the most compelling witnesses were there, “neutral” C-Span simply did not show up. The final, “official,” report, itself one large lie, was made available to Henry Kissinger, one of the chief architects of the cover-up, before its finalization, so he could remove anything still in the report that he didn’t like. The dishonesty that permeated the Federal Government at its highest levels was laid bare before me, the family members of the betrayed POWs, and the rest of the crusaders for their return; but the general public saw, and believed, only the lie.

Today, the lying, cover-ups and self-serving, arrogant abuses of power, at the expense of the voting process, our Armed Forces, ordinary citizens, and a few courageous truth-tellers, is coming out in the open, exposed by the honest reporting of Fox News, talk

radio and, lately, even a few of the establishment media outlets, heretofore establishment lap dogs, rather than truth-telling watch dogs. Let us pray for an explosion of this truth, and justice for those who commit self-serving crimes, and then arrogantly lie to Congress and the public concerning them.

HAVE YOU NOTICED THE POW/MIA FLAGS?

In the 70s, 80s and 90s, we had to fight to get the POW flag flown, even at county courthouses; we had to go to court in some places. We had to fight through Congress to get it flown (reluctantly) one day a year in DC. Today, there is an explosion of display of the POW flag; it is required at every US Post Office; I see it everywhere. They flutter in the breeze all over the government buildings in DC.

How do we explain the radical, dramatic change? I have an informed opinion: “they” (the ones who fought so desperately to hide evidence of live POWs abandoned in SE Asia—plus 8,000 in Korea and at least 25,000 in World War II and several hundred in Siberia in 1919), and to discredit that evidence which they could not conceal, are confident that they have won. They believe that you, I, and others who know the truth have lost the fight, and they are right.

Are there live American warriors abandoned in SE Asia, still there, and in other places? Absolutely—hundreds of them. But they are at least 60 years old now, dying daily, and they no longer speak English except in its crudest forms. Those who survive as you read this are fluent in Vietnamese, Lao, Cambodian, Chinese or Russian, depending on where they have been held.

The evil men and women behind these enormous crimes of betrayal will someday kneel, trembling, before an incorruptible, all-knowing Judge. And, on that Judgment Day, Henry Kissinger’s statement about those of us who fought to rescue our betrayed warriors (“I just can’t understand all this fuss over a few soldiers”) will be explained to him by the One seated upon the Judgment Seat of Christ; and, for him and the others like him, it will be too late.

(Rev 20:10-15).

POLITICS AS USUAL AND LYING

One thing that I learned in my years in DC is that politicians, their staffs and bureaucrats, lie as a way of life, but they are careful never to use the words “Lie,” “Lied,” “lying,” and—especially—“liar.” They do it daily, but are careful not to call it that. An ordinary lie becomes “mis-spoke.” A larger lie becomes “disingenuous.” A real whopper of a lie becomes “less than forthcoming.” I am happy to report that I am feeling some fresh air leaking into the cesspool of DC politics. Once in a while, lately, I am hearing even members of Congress let words like “lie,” “lied,” and “lying” slip out in public. I find this enormously refreshing.

THE BOY SCOUTS FINALLY CAVE—SORT OF

At least a generation ago Girl Scouts of America (GSA) was co-opted by radical feminists. Bertty Friedan was elected to the National Board of Directors in 1975, and she was so radical that she considered Gloria Steinem “soft” on feminism. GSA is closely affiliated with Planned Parenthood (need I say more?). I no longer buy cookies from those innocent little Brownie Scouts, but don’t try to explain—neither they nor their mothers, who are watching, could understand.

But the Boy Scouts (BSA), god bless them, have withstood the ceaseless pressure from the atheists and sodomites—that is, until now. In May the national board, while still standing strong against the atheists, made a partial surrender to the sodomites. They will still not allow homosexuals to be scoutmasters, or occupy positions of leadership at other levels; however, as of 1 Jan 2014 they have agreed to accept homosexuals as scouts. Although the details of their internal discussions are unknown to us, the reasonable assumption is that we are talking about open, practicing homosexual boys.

We must ask why they gave in to this, and the answer seems to be money. Historically, the BSA has received much financial

support from large corporations and foundations. With this support BSA National has bought a huge amount of mountain property in West Va. for camping and training. But the sodomy power structure has persuaded the supporting foundations/corporations to demand this compromise or lose their financial support. This would leave BSA with an enormous unfinished project, no money with which to finish it and, probably, a debt it could not pay.

The reaction to the announcement was dramatic and immediate. The Southern Baptist Convention cut off all financial support, but is leaving it up to local congregations as to whether or not to host Boy Scout troops and Cub packs (most troops and packs meet and function in local churches). The problem is being discussed in other Protestant denominations and the Roman Catholic Church, but final decisions may be some time in coming. The leadership of the Assemblies of God has predicted “a mass exodus” from BSA, and is building a similar program of its own. The Mormons, the group that hosts by far the largest number of Boy Scout troops and Cub packs, announced immediately that they will continue total support for the BSA with no change. Perhaps I am cynical, but this doesn’t surprise me; their widespread and generous support of the BSA is also a priceless recruiting program for Mormonism.

Incidentally, leaders of the sodomite pressure groups have already announced that they will not end their campaign against the BSA until they accept sodomites as scoutmasters and other leaders. EXODUS INTERNATIONAL CLOSSES ITS DOORS

Exodus International, which for decades has been a Christian ministry dedicated to setting homosexuals free from that sinful,

destructive lifestyle through faith in Jesus Christ, with 260 member ministries World-wide, is closing its doors. The Exodus leadership has been moving away from its founding, biblical principles for several years, trending more to policies compatible with the secular culture. This policy change became obvious when Alan Chambers, President of Exodus, suggested last year that practicing homosexuals can still receive the salvation offered by Jesus Christ. R. ONE NATION UNDER ALLAH?
